

PAYMENT PLANS

All tuition and fees are non-refundable.

All families are billed through FACTS Tuition Management on a monthly or annual basis.

• MONTHLY Payment Plan:

- 12 automated payments beginning in June and concluding in May
- 10 automated payments beginning in August-May for state scholarship recipients

• ANNUAL Payment Plan:

- Tuition is paid in full by August 1st

Please note, there is a \$55 FACTS enrollment fee per family per school year that is automatically billed when the account is activated.

TUITION & FEE PAYMENTS

- Due the 1st of each month and are past due after the 10th.
- Payments made through a credit/debit card are assessed a 3% processing fee. Zero fee for ACH.
- All accounts that are not paid by the 10th of the month will be considered past due and will be charged a \$35 late fee.
- Any returned payments will be subject to a \$50 return payment service fee.
- Any account that is 15 days past due will be denied access to RenWeb and school records.
- Any account that is 30 days past due, the student will be suspended from school until the balance is paid in full.
- Final, end-of-year payments must be made in full by May 10th in order for students to complete their final exams. Only cash or cashier's check payments will be accepted after May 10th.
- Report cards and school records will be released once all account balances are paid in full.
- Students with delinquent accounts may not be permitted to attend Extended Care or participate in extracurricular activities and events.
- If you withdraw your student, you are financially responsible for the balance owed, irrespective of the payment plan chosen, regardless of the withdrawal date.
- A penalty for withdrawal will be assessed equal to one month of the full tuition.
- A \$100 charge will be assessed for a request to change the tuition plan.
- TMA families with a Step Up for Students scholarship should be aware that they are ultimately responsible for the full cost of tuition and fees should their funding not be released by Step Up.

Other restrictions may apply.
